### What is a Written Statement

An official document from the Tax Assessor/Collector or his deputy showing the amount of delinquent taxes, penalties, interest and any known costs or expenses due the taxing jurisdictions for specific properties, wholly or partially in Hunt County, owned by an individual or a company.

A Written Statement is required by the Hunt County Sheriff Department before participating in the "first Tuesday" tax sale/auction of properties being sold due to non-payment of property taxes.

Request for Written Statement

#### What is the cost for a Written Statement?

There is a non-refundable fee of \$10 for each Written Statement issued.

## Are any other documents required in order to purchase a Written Statement?

In addition to the \$10 fee, a notarized Request for Written Statement is also required. The Request for Written Statement must be the original signed and notarized document; copies are not permitted.

#### Information required in the Request for Written Statement:

- Name of person/company requesting the Written Statement
- Mailing address of the requesting person/company
- List of all Hunt County property currently or formerly owned by the requesting person/company
  - The list must include all property located in Hunt County, whether partially or wholly located in Hunt County
  - Additional pages may be attached, if needed
- Original signature
- Notary seal and original signature

## When does a Written Statement expire?

The Written Statement is valid for 90 days from the date issued.
